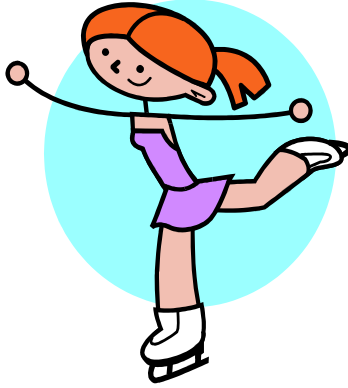


# Come Skate in ISCC's 2008 Spring Ice Show!

Important things to know:

**Participation:** All participants of the Learn to Skate program, Kid's Class, Freestyle & Adult Workshops, Charter Oak Figure Skating Club Members, and those skaters who skate and train at ISCC are eligible to participate in the show.

Participation fee is \$75. The fee will cover ice time, coaches and costume accessories. Each participant will be responsible to provide their own basic costume.

Each participant will be in one group number based on age and ability, as well as the closing number.

Each participant must attend all of the rehearsal dates. Please check with Shannon Pastizzo, Learn to Skate Director if there is a scheduling conflict.

**Admission:** Show admission is \$5 per person, with children 2 and under free. Participants will receive one chaperone pass and one skater's pass for the show.

Tickets will be on sale at the International Skating Center of Connecticut starting on April 20, 2008 at the front desk.

Doors for the show will open for general admission seating 15 minutes before show time.
